From an environmental point of view, the scope mainly includes all activities in the handling of hazardous sub-stances and substances hazardous to water. This also includes the storage of hazardous / water-polluting sub-stances, especially paints and heating oil, and the disposal of hazardous waste.

The most environmentally relevant area is our own production plant for industrial paintings, in which Roth Hydraulics GmbH products are provided with special coatings and paints according to customer requirements.
